WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Annapurna Shikshan Prashikshan Sansthan, Balaji Nagar, Maonda R.S., Neem ka Thana, Distt. - Sikar - 332711, Rajasthan has submitted an application (Code No. APN-04815) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred) students on 05.10.2007.

- AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms,
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Annapurna Shikshan Prashikshan Sansthan, Balaji Nagar, Maonda R.S., Neem ka Thana, Distt. - Sikar - 332711, Rajasthan for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred Only) students from the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
 - The admissions in the institution so recognized for the academic 1) session 2008-2009 shall be made only after affiliation by the examining body, before the commencement of the academic year and the admission of the admission of the students shall be completed well before the cut of date prescribed by the examining body for the academic year 2008-2009, failing which the recognition will be deemed to be for the next year acade nic year that is 2009-2010.

Formal orders for recognition / permission will operate for 2008-2009 ii) only if requirement of 180 teaching days in the session would be fulfilled as per calendar of the University / Affiliating body. The decision of the University in this regard shall be final.

The institution shall, within one month of the receipt of recognition 111) order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional

The institution shall comply with the various other norms and standards IV) prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be by other regulatory bodies like UGC, affiliating University Body, the State Government etc, applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw it a recognition as stipulated provisions of Section 17(1) of the NCTE Act. Chicheste - eth Livilla
